A team of three researchers (Baker, Howard, Swain) are focused on exploring race and racism in rural education, specifically along the Black Belt to forward questions, inquiries, and methodological (quantitative, qualitative, and

mixed-methods) approaches used in the field of rural education. Presently, three manuscripts have been published or drafted. This long-term project will seek to create a network of scholars and practitioners working on rural racial equity research.

Co-Investigator, Lawrence Public Schools Turnaround Project: Oppression at the Intersection: State Takeover Legislation and the Hostile Takeover of an Urbanizing School District

This research covers instances of state takeover as they intersect with race and ethnicity, specifically where Afro-Latin@ populations exist. There is a paucity of research on state takeover districts and their impacts on urbanizing school districts. In this panel presentation, we evaluate the development, implementation, and consequences of state legislation aimed at reconstituting or taking over, public schools and school districts in an urbanizing Northeastern city. Collectively, we find that the state takeover of this mid-sized Northeastern city left Afro-Latin@ students, parents, and community members with perceptions of betrayal and political powerlessness.
